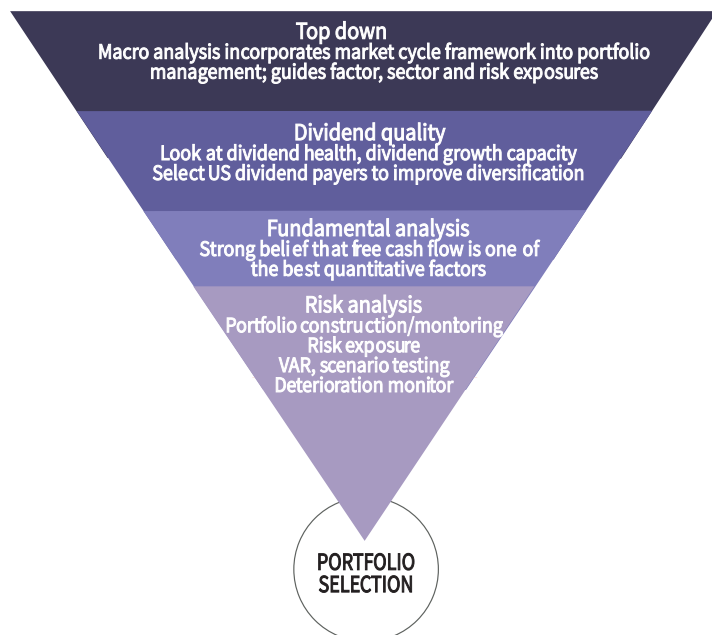

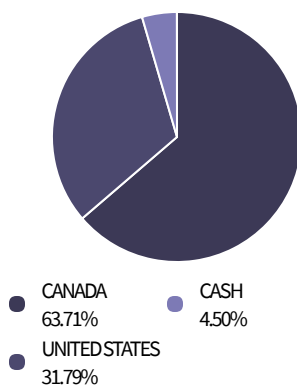
GROWTH OF \$1,000

AS OF JAN 29, 2021



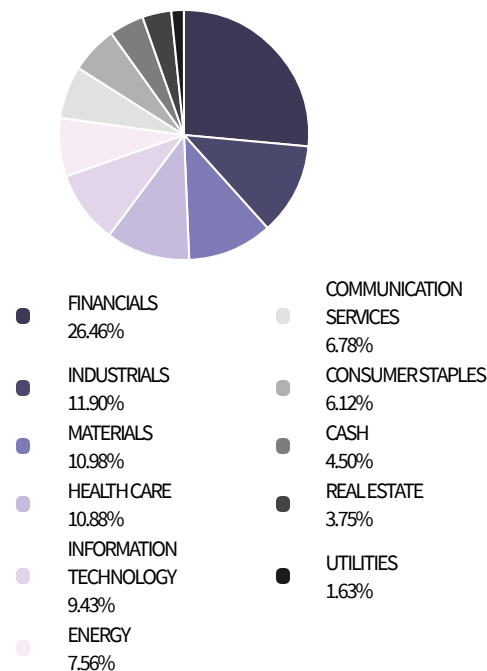
GEOGRAPHIC BREAKDOWN
