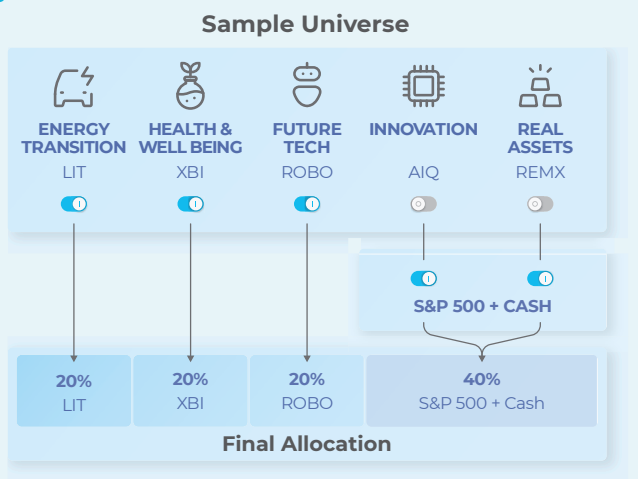

Investment Process

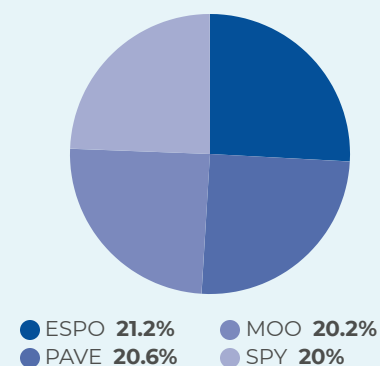
- 1 Measures momentum across universe of thematic ETFs.
- 2 Selects those with highest momentum scores for inclusion.
- 3 If less than 5 positive momentum themes exist, remainder is allocated to 50% broad US Equity (S&P 500) and 50% Cash.
